## Statement of Evidence

In 1864, C. E. Davis and J. W. Webb, Jr., did the original subdivision of the township.

In December 1912, John Norgaard used a corner set by land owner in 1895. He said he had set a post in the original government mound. In 1912 Norgaard measured 1333' from the north line of the NE  $\frac{1}{4}$  to the road along the south line of the NE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$ .

On May 4, 2007, Bueltel-Moseng Land Surveying set the corner using the recorded distance from the intersection of the fence and the centerline of the field road at the center of the section and single proportionate distance from the 1912 survey. Then we measured from the north line of the  $NE_{\frac{1}{4}}$  to the south line of the  $NE_{\frac{1}{4}}$  of the  $NE_{\frac{1}{4}}$  and checked to the 1333' from the 1912 survey. We set a 1" iron pipe with seal #43844 at the corner
