## STATEMENT OF EVIDENCE

East Quarter Corner of Section 28, Township 116 North, Range 41 West, 5th P.M.

In 1865, GLO surveyors Edward Davis & Watson Webb set post in mound with pits to mark the corner.

Page 404 of the large Book of Surveys, located in the office of the Yellow Medicine County Recorder, contains a survey by County Surveyor, John Norgaard, dated June 1918. Mr. Norgaard notes "Found stake in road as where set in Govt mound by adjoining landowners about 27 years ago" and the following ties:

Telephone pole 29.4' West Fence corner 23.7' due east

A 1938 historic aerial photo obtained from the U of M Historical Aerial Photo Online Library depicts a north-south road and occupations lines east and west of the presumed corner location.

In July 2023, the DNR survey crew searched for evidence of the corner and located a large landscape spike down 0.3 feet in a north-south road and at occupation east and west. The DNR returned to the corner in August 2023, and, with the assistance of a Wildlife backhoe operator, excavated at the occupation in the gravel road. A 10 foot by 6 foot hole was excavated. Natural grade was found at a depth of approximately 1.5 feet. At a depth of about 3 feet, the remains of a pointed wood post was recovered, standing vertical.

The found post was approximately 0.7 feet southwest of the found spike and in the center of the north-south road and on line with a fence line west and a field division east. Further analysis of the occupation lines show that it is substantially unchanged since 1938, per the air photo. Based on all the given facts, it is presumed that this is the post that was referenced in the 1918 survey by John Norgaard and marks the location of the original government corner. A ¾" x 18" rebar with cap stamped "MN DNR LS 47461" was set over the found post and down 0.3 to perpetuate the corner position.
