

**Statement of Evidence**

**North Quarter Corner of Section 34, Township 115 North, Range 38 West, Yellow Medicine County, Minnesota.**

1864 C.E. Davis & J.W. Webb, Jr. set post for quarter section corner from which  
Ash 12" N.10°E. 20 links.  
Elm 10" S.40°W. 18 links.

1891 Jonah Peterman set a post at the corner. He set it 2640' east of the NW corner of section 34. During this survey he established the position of the NW corner as he was unable to find it.

1897 Jonah Peterman determined the true location of the corner based on the remnants of the old bearing trees and notes that the 1891 survey should be changed.

1919 John Norgaard measured 2656' from the NW corner of section 34 to the N1/4 corner. This survey appears to have been done for a mortgage company and his notes are somewhat vague.

2024 FWS searched multiple times with magnetic locator and ground penetrating radar. I searched at both the recorded distance of 2640' from the GLO survey and the 1891 Peterman survey and the distance of 2656' from the 1919 Norgaard survey. I did not find a monument at the corner. I was able to find remnant fence running to the south and north. The fence has an angle point where another piece of remnant fence ties into it from the southeast. The position of the fence intersection is 2652.1' east of the NW corner. I set a 1 inch diameter by 30 inch long aluminum post with a marked aluminum cap at the intersection of the remnant fence lines.
