

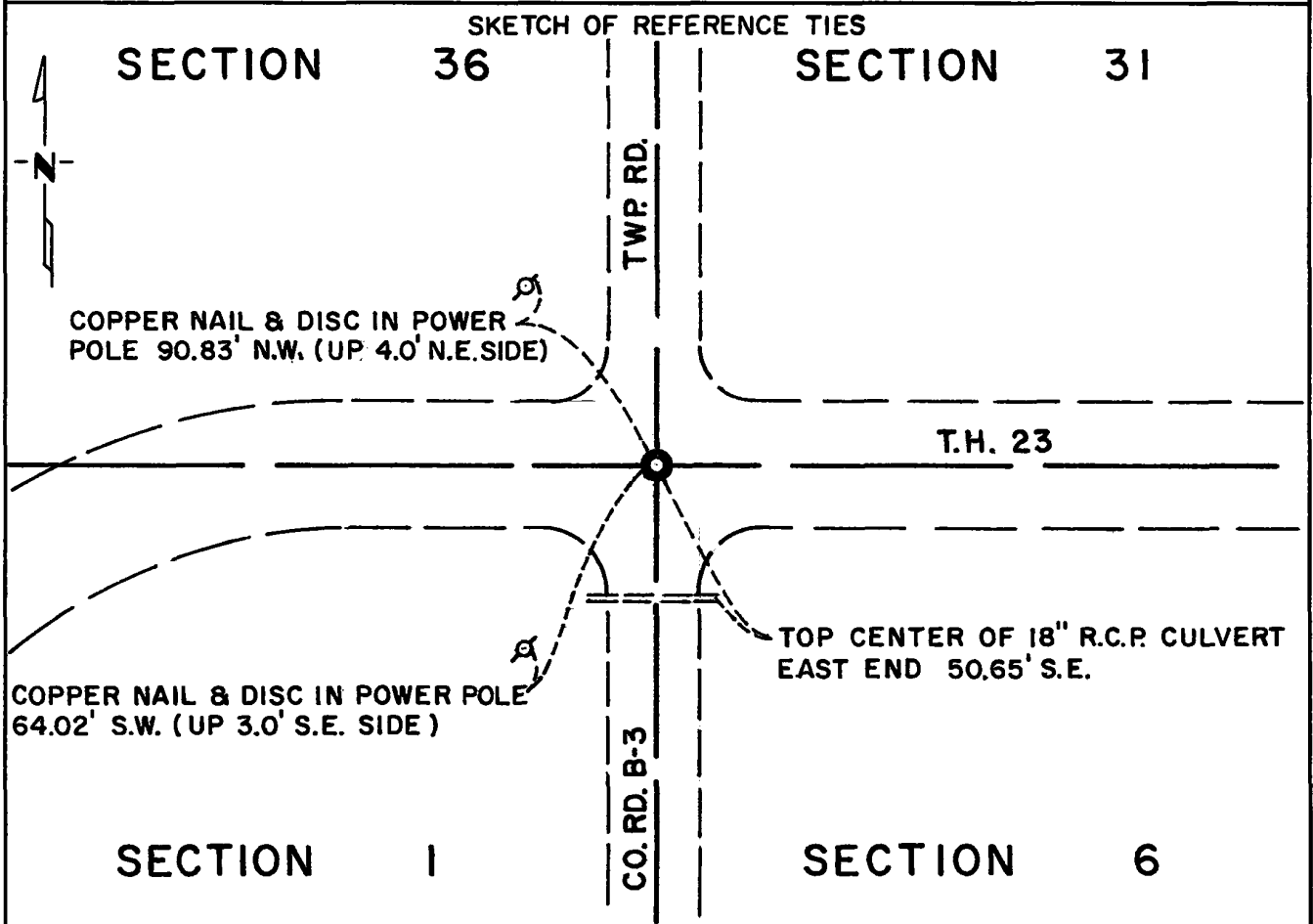

**Statement of Evidence:** N.E. Cor. Sec. 1, T115N, R40W.

The original Public Land Survey of the township line was completed in 1858 by W. J. Neeley. A wood post was set and coal was deposited in a mound of dirt with trenches and pits to mark the corner.

John Norgaard, the County Surveyor, states in his 1913 survey notes that he found an iron monument marking the township corner and that the iron monument was set in the government mound in 1896.

1931 Minnesota Highway Department notes show that a square iron and a wooden stake were found marking the township corner. The notes show the corner as being 0.5 feet south of engineer's station 79+96.5 (T.H. 23).

In May 1976, a Minnesota Highway Department survey crew searched the area shown on the R/W map with a metal locator. There was some indication of iron. Being this is a concrete pavement, no excavation was made for the corner.

On December 21, 1976, a Mn/DOT survey crew set a cast iron monument at the location shown on the R/W map, that is 0.5 feet south of T.H. 23 engineer's station 79+96.5.

This location is accepted as the government corner because it fits the location as shown on the R/W map which has marked the corner for at least 45 years and it also fits occupation lines.

**Statement of Evidence:** E¼ Cor. Sec. 1, T115N, R40W, 5th P.M.

- 1858 - The original Public Land Survey of the township line was completed by W. J. Neeley. A wood post was set over deposited coal in a dirt mound with trenches and pits to mark the corner.
- 1913 - John Norgaard, County Surveyor, located the corner midway and on line between section corners. He also did this in 1915 but did not state whether he set anything to mark the corner in either case.
- 1976 - The Minnesota Highway Department excavated a 7 foot by 8 foot by 3½ foot deep hole to natural ground at the intersection of the centerline of a north/south road with a fence line west. Nothing was found marking the corner.
- 1976 - Mn/DOT set a cast iron monument 4 inches below the road surface at the lost location.

The lost location is accepted as the position of the government corner because the County Surveyor set the corner at this position 63 years ago and it also fits the occupation lines, that is, at the intersection of the centerline of a north/south road and a fence line west.

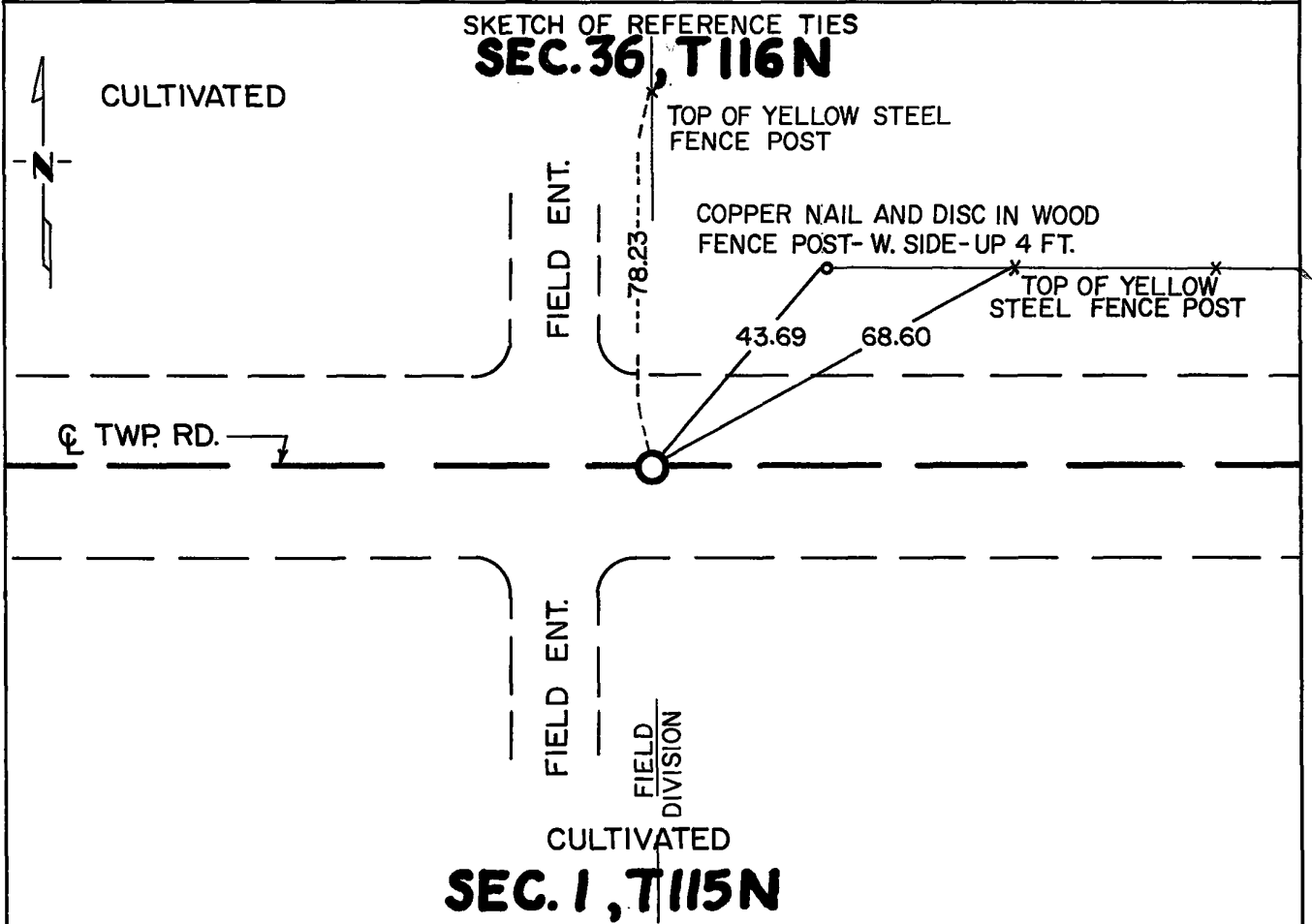

Statement of Evidence: North Quarter Cor. Sec. 1, T115N, R40W

- 1858 - The original Public Land Survey of the township line was completed by W. J. Neeley. A wood post was set over deposited coal in a dirt mound with trenches and pits to mark the corner.
- 1913 - John Norgaard, County Surveyor, set a stone on line and equal distances between section corners to mark the quarter corner for a survey of Section 36, T116N, R40W.
- 1915 - John Norgaard used the same stone for a survey in Section 1.
- 1976 - A Minnesota Highway Department survey crew excavated a 3 foot by 6 foot by 2½ foot deep hole and found a 6"x6"x12" stone marking the corner. It is 2.3 feet below the present road surface and about 2 inches below an old road bed in natural ground. The stone is at the centerline of an east/west road, 2 feet east of a north/south fence line north and on line with a north/south field division south.
- The stone is accepted as the location of the government corner because it fits occupation lines and has marked the corner for 63 years.

A Minnesota Highway Department cast iron monument was set above the stone and 4 inches below the road surface.

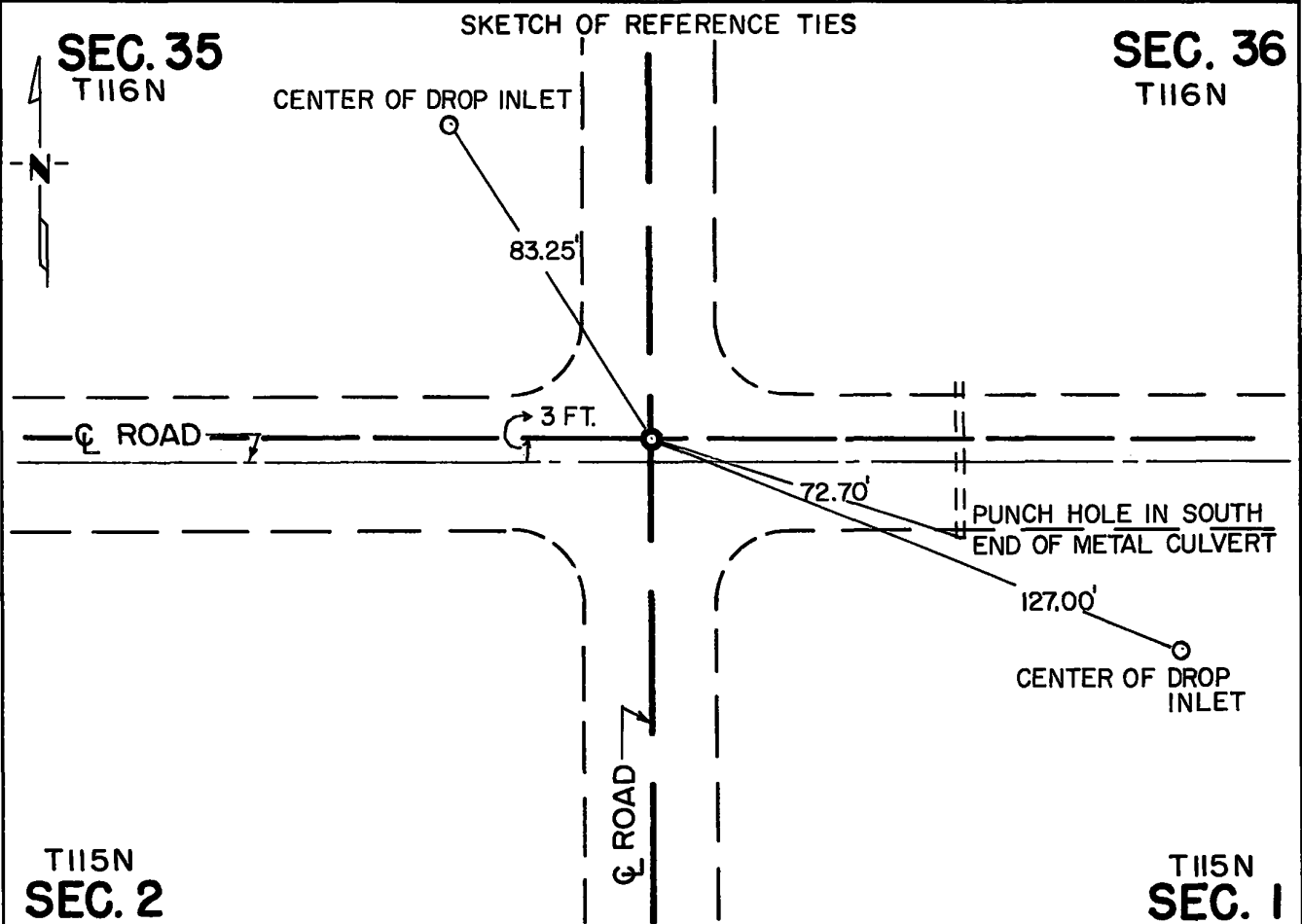

Statement of Evidence: Northeast Cor. Sec. 2, T115N, R40W

- 1858 - The original Public Land Survey of township line was completed by W. J. Neeley. A wood post was set and coal was deposited in a mound of dirt with trenches and pits to mark the corner.
- 1901 - John Norgaard, the County Surveyor, found a stone in the government mound and set a 6"x6"x24" granite monument in the mound to mark the corner. He used this monument on subsequent surveys in 1913 and 1915.
- 1937 - The County Engineer replaced the granite monument with a 6"x6"x24" concrete monument.
- 1976 - A Minnesota Highway Department survey crew excavated a hole 4'x4'x 3½' deep. A 6"x6"x24" concrete monument was found 18" below the present road surface. There was nothing under the concrete monument. A Minnesota Highway Department cast iron monument stamped N.E. Cor. Sec. 2, T115N, R40W was placed over the concrete monument and about 3" below the road surface.

An analysis of this data provides a continuous chain of record perpetuating the location of the original Public Land Survey Corner.

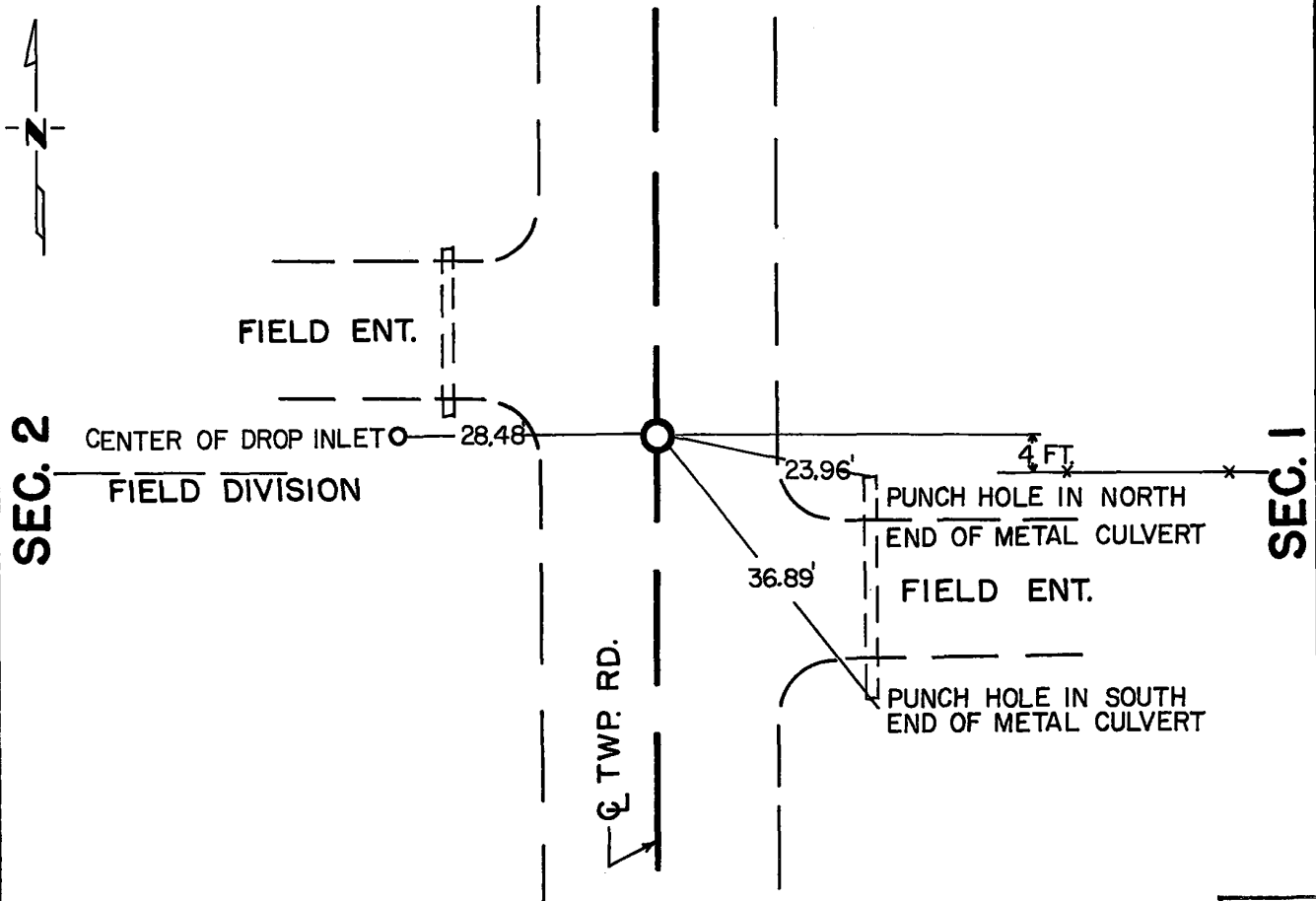

1864 - The original Public Land Survey was completed by C. E. Davis and J. W. Webb, Jr. A wood post was set in a dirt mound with trenches and pits to mark the corner.

There is no record evidence that anything has been set to mark the corner since the original Public Land Survey.

1976 - A Minnesota Highway Department survey crew excavated a 5 foot by 9 foot by 4½ foot deep hole to natural ground at the intersection of the centerline of a north/south township road and an east/west fence line east and a field division line west. Nothing was found marking the corner. The hole extended 2 feet north, 7 feet south and 2.5 feet east and west of the lost location. A Minnesota Highway Department cast iron monument stamped E¼ Cor. Sec. 2 was set at the lost location, 3" below the road surface, at the centerline of the north/south road and 4 feet north of the east/west fence line east.

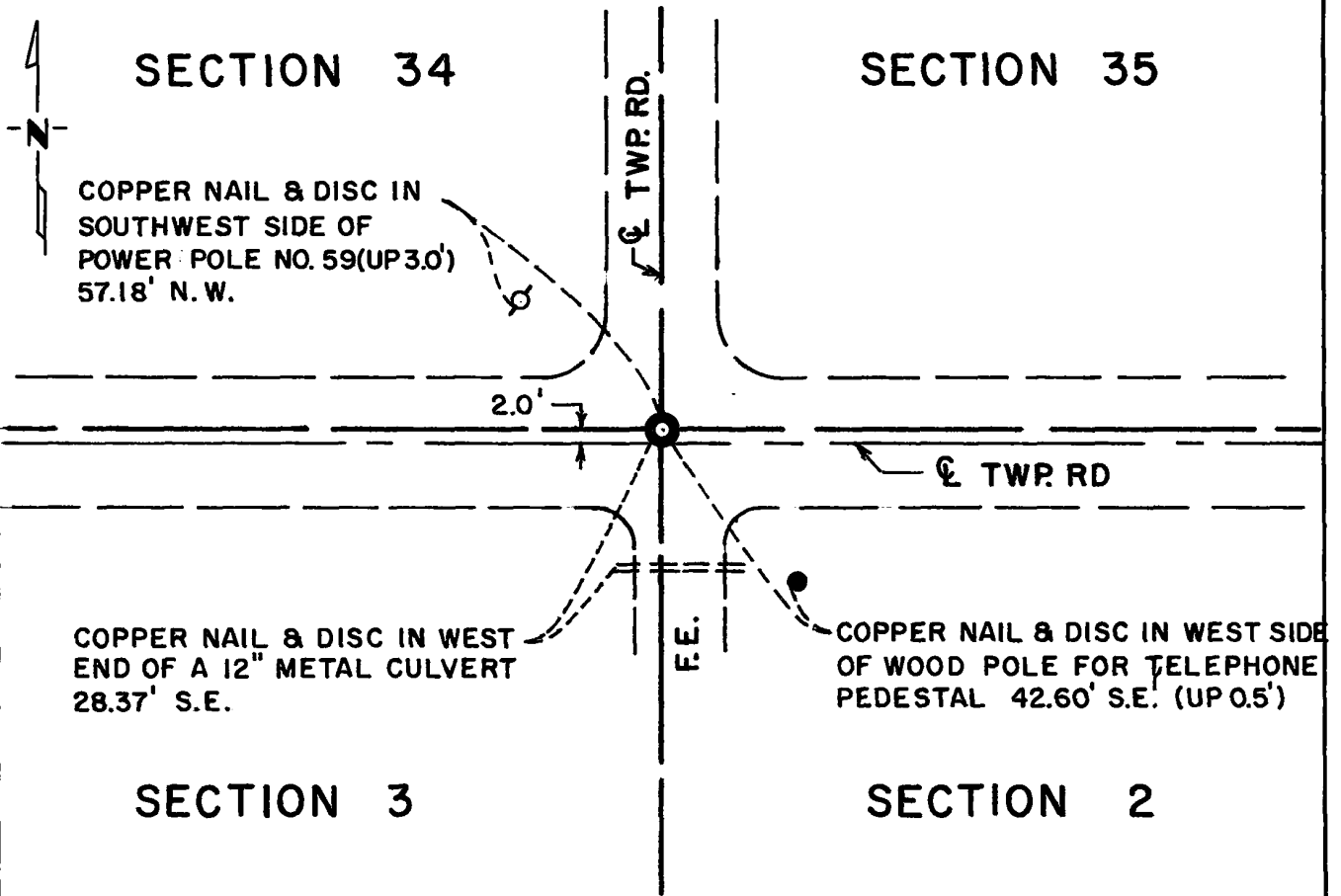

- 1858 - The original Public Land Survey of the township line was completed by W. J. Neeley. A wood post was set over deposited coal in a dirt mound with trenches and pits to mark the corner.
- 1901 - John Norgaard, County Surveyor, found a stake and stone reported to be set in the government mound by the previous County Surveyor. A 6"x6"x24" granite mounment was set to mark the corner.
- 1915 - John Norgaard found the granite monument and used it in a survey of Section 3.
- 1976 - A Minnesota Highway Department survey crew excavated a 20 foot by 8 foot by 3½ foot deep hole to natural ground. Found an old road bed about 1½ feet below present road surface. Nothing was found marking the corner. The hole was dug at the intersection of the centerlines of an east/west road and a north/south road north and a field division line about one-half mile south.
- 1976 - After an analysis of the record data compared to the electronic field measurements, it was decided to excavate north of intersection and at lost location. On November 10, 1976, excavated a 8 foot by 20 foot by 3.5 foot deep hole. Found a 6"x6"x24" granite monument 1.7 feet below present road surface and 2 inches below an old road bed. Monument is on centerline of a north township road and 2 feet north of centerline of a east-west township road. Found old lath on north and east side of monument. Drove 3/4"x24" iron pin along east side of granite monument. On November 24, 1976, placed MHD cast iron monument above granite monument. An analysis of this data provides a continuous chain of record perpetuating the location of the original Public Land Survey corner.

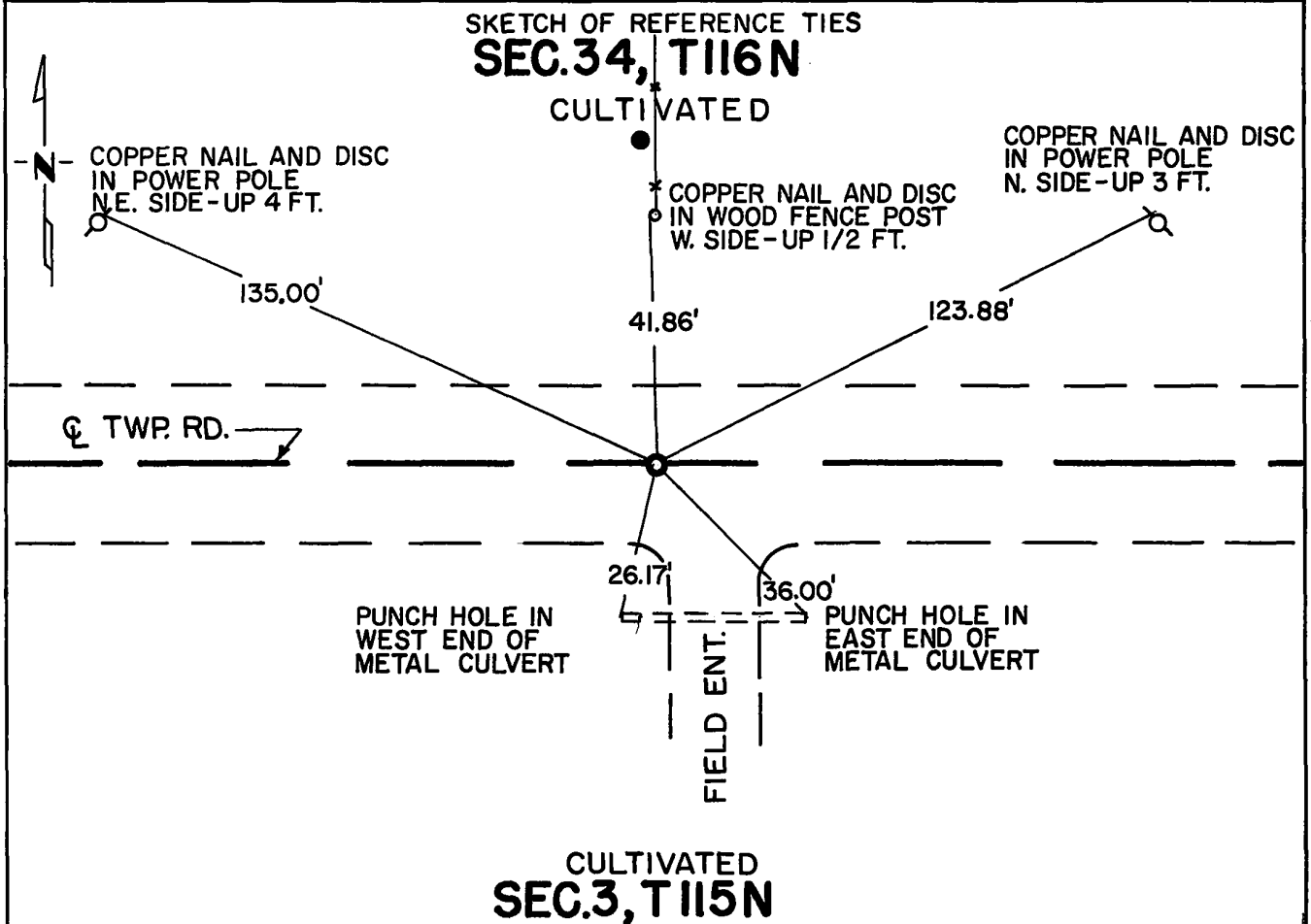

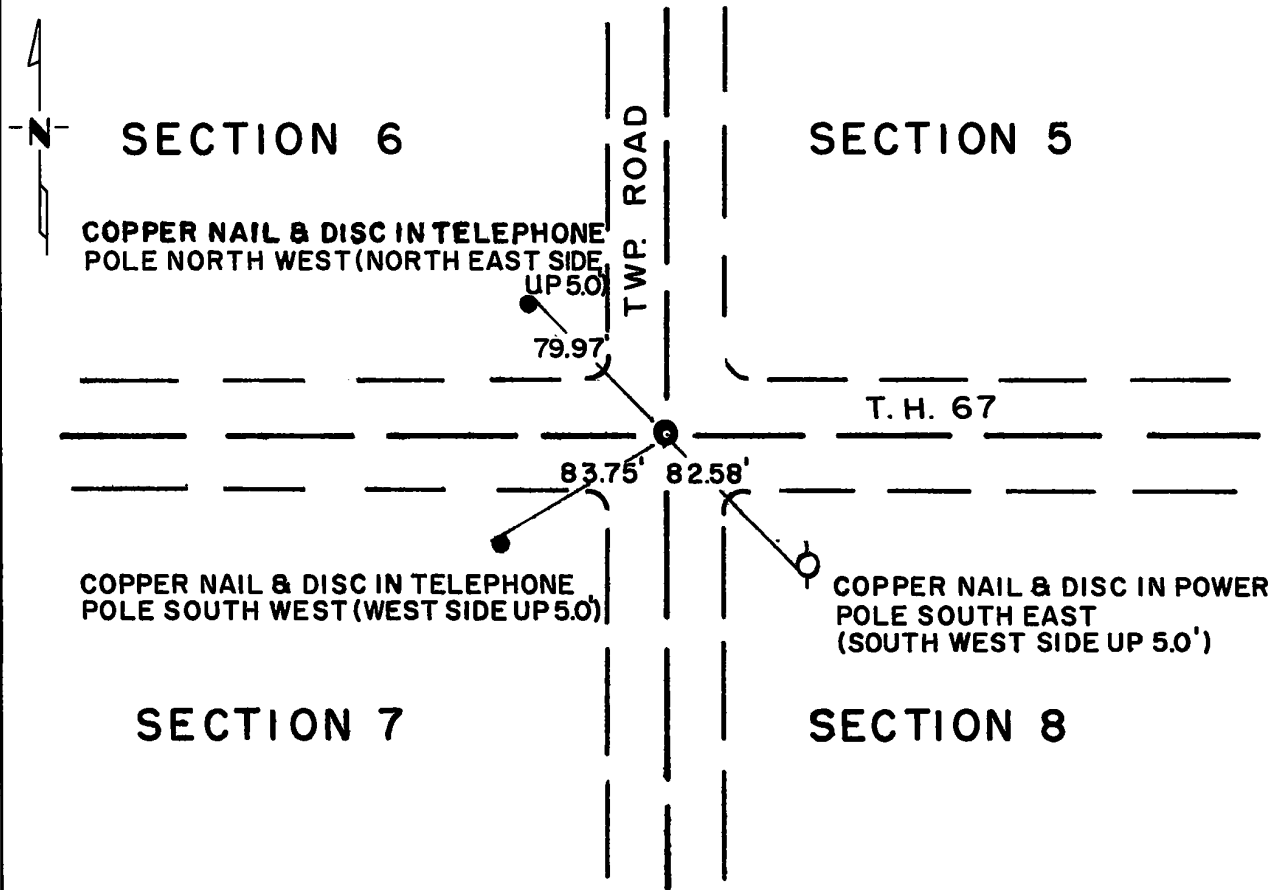

In 1895 and 1901 John E. Norgaard found a stone in place. In 1901 he replaced the stone with a 6 inch x 6 inch x 24 inch jasper monument.

Prior to 1956 the Minnesota Highway Department right of way map shows a  $\frac{1}{2}$  inch iron rod in place.

On May 22, 1974 the Minnesota Highway Department found the  $\frac{1}{2}$  inch iron rod on centerline of North-South road and 1.0 foot North of centerline of East-West highway (T.H. 67).

I could not determine who replaced the jasper monument with the  $\frac{1}{2}$  inch iron rod.

On July 19, 1974 the Minnesota Highway Department placed a cast iron monument with  $\frac{3}{4}$  inch iron pin below it to mark the corner.



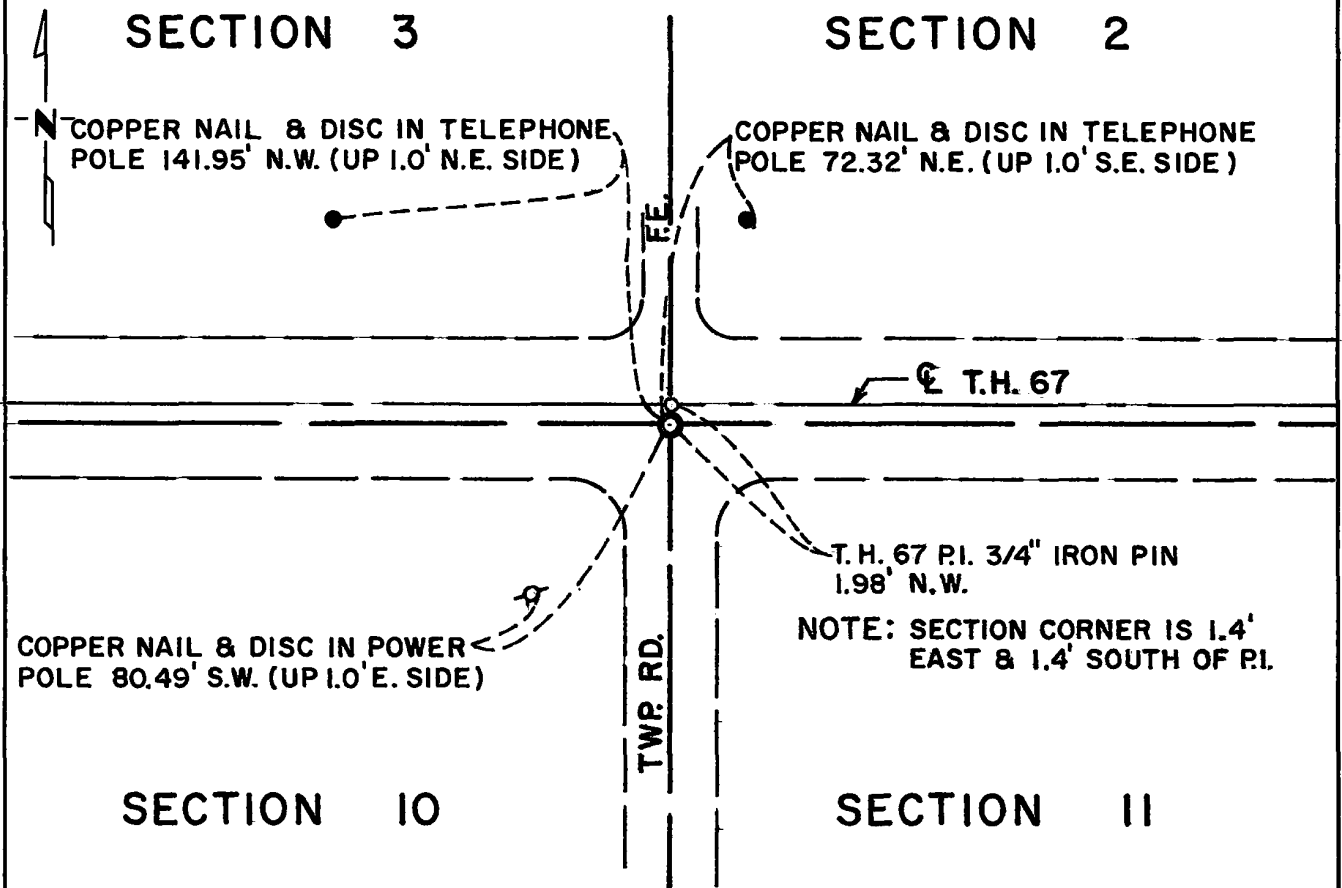

The original Public Land Survey was completed in 1864 by C. E. Davis and J. W. Webb Jr. A wood post was set in a dirt mound with trenches and pits to mark the corner.

In 1901, John Norgaard, the County Surveyor, found a stone in the government mound and set a 6" by 6" by 24" granite monument in the mound to mark the corner.

In 1931, a Minnesota Highway Department survey crew found the granite monument at the section corner. The notes show that the granite monument is 1.4 feet east and 1.4 feet south of the point of intersection of tangents engineer's station 53+20.3 (T.H. 67). The notes also show that the survey crew removed the granite monument but did not show whether or not the monument was replaced.

In 1976, a Mn/DOT survey crew found an iron pin at T.H. 67 P.I. Station 53+20.3. No excavation was made for the section corner because it was felt that nothing was in place and the P.I. had been perpetuated since 1931.

In 1976, a Mn/DOT survey crew set a cast iron monument 1.4 feet south and 1.4 feet east of said P.I. 53+20.3.

An analysis of the record data provides a continuous chain of perpetuation for the location of the government corner.

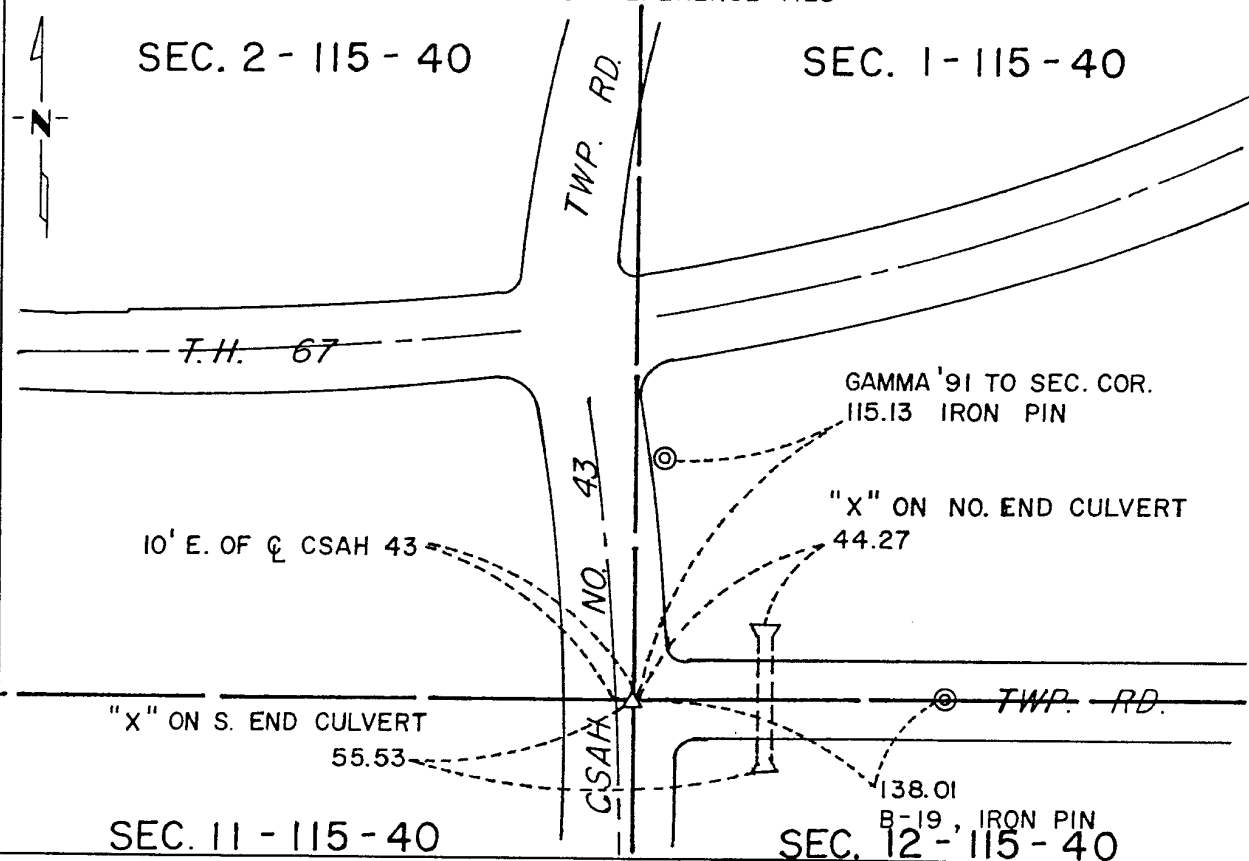

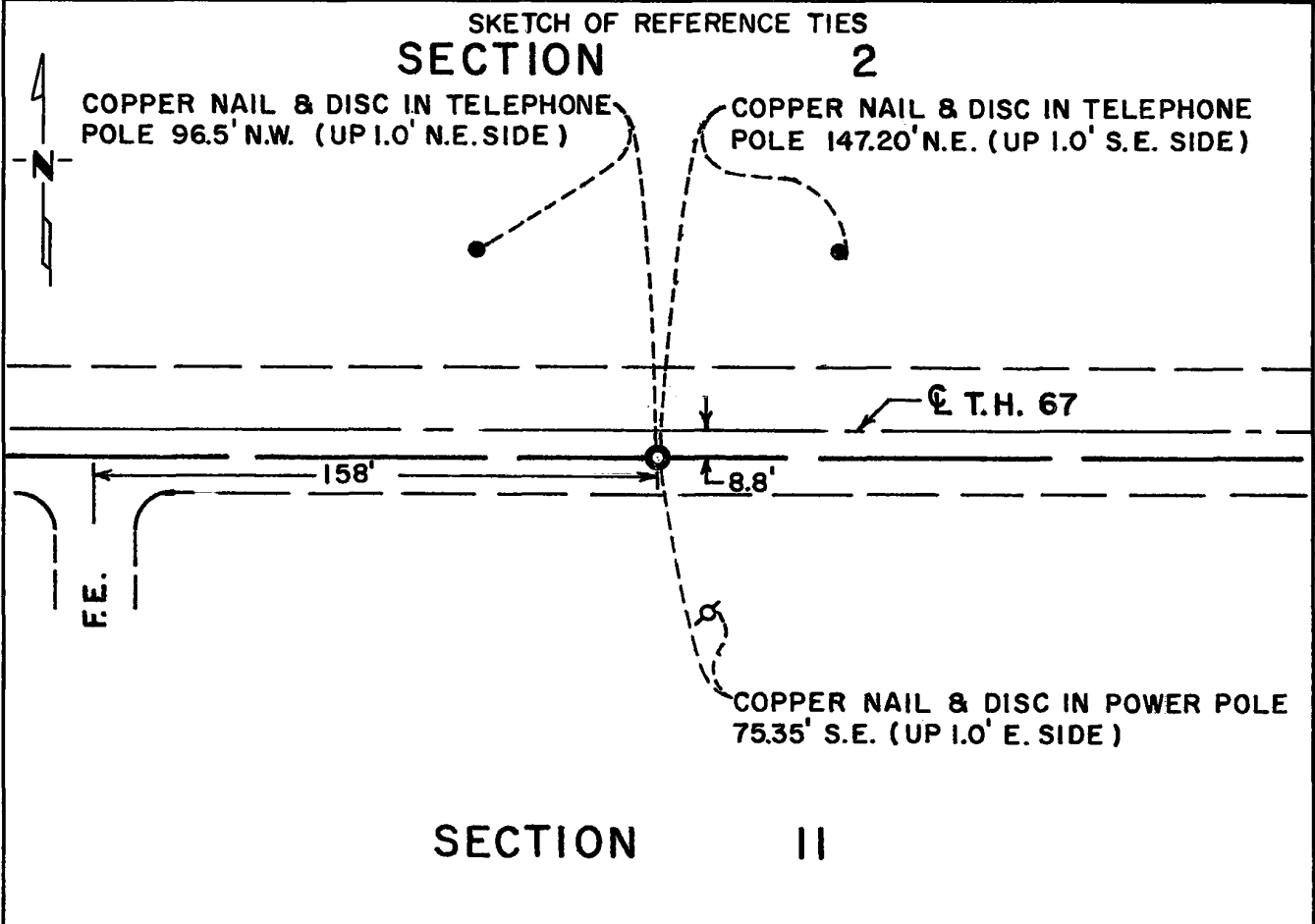

The original Public Land Survey was completed in 1864 by C. E. Davis and J. W. Webb, Jr. A wood post was set in a dirt mound with trenches and pits to mark the corner.

There is no record evidence that anything has been set to mark the corner since the original Public Land Survey.

The Minnesota Highway Department surveyed the centerline of T.H. 67 in 1931. The notes from this survey show that the northwest corner and the northeast corner of the section were found but not the quarter corner. An analysis of this data provides a continuous chain of record perpetuating the location of the original Public Land Survey corner.



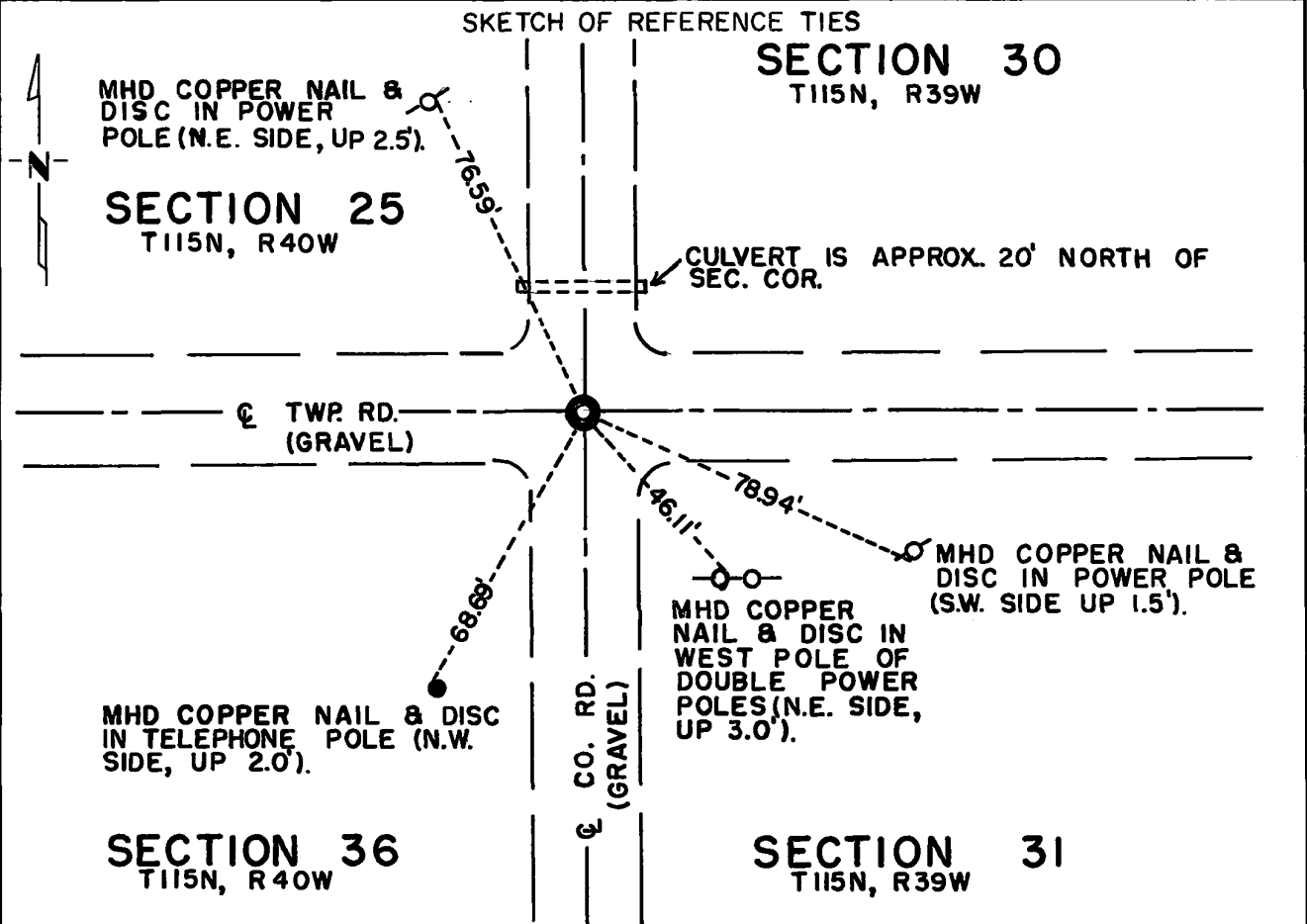
